At the outset of meeting Director /Projects, DHBVN Hisar welcomed all the participants. The Director/Projects emphasized that the DDUGJY and IPDS scheme is a flagship scheme of Govt. of India and important for DHBVN as electrification work in rural and urban areas is included in this scheme. It was also conveyed that as letters of award have been issued to the turnkey contractors foremost of the DDUGJY and IPDS works and thus it was required to sensitize all the stake holders for newly awarded projects and to review the already awarded projects thus present meeting was called.

The firm has intimated that Civil work has been commenced recently.

The Director/Projects has intimated to XEN/Civil, DHBVN, Hisar to make the provision in civil BOM for Submersible Pump Set for drinking water if the water is suitable for drinking purpose. However, field officers have insisted that provision of Submersible Pump Set be made compulsory in civil BOM.

All the turnkey contractors have assured that the pending works will be completed within schedule time. Director/Projects has further emphasized that quality in work should not be compromised at any cost and XEN/Const. and his team should closely monitor the same through frequent site visits.

8. Implementation of DDUGJY / IPDS Projects:-

Various points related to the project implementation were discussed in detail and the followings aspects have been discussed, decided and agreed in the meeting:-

- 8.1 The Director Projects emphasized that the implementation of said scheme is to be done jointly in true letter and spirit by all the stakeholders i.e. DHBVN, Project Monitoring Agency (PMA) and Turnkey Contractors. He further conveyed the importance of proper Quality checks in the scheme to be carried out while execution of projects.
- 8.2 The Director/Projects directed to use the videography during Quality and Quantity checking while implementation of the project. The proper record of videography in the form of CD / DVD strictly be maintained at the level of PMA, Turnkey contractor along with every inspection report.
- 8.3 The turnkey contractors were directed to communicate their issues / grievances, if any, at an early stage in writing to DHBVN for timely resolution of the same.
- 8.4 It was agreed that the village wise list of BPL beneficiary, where electric connections are to be released under the DDUGJY scheme will be provided by the Nodal officer of the project to the Turnkey Contractors centrally.
- 8.5 The list for replacement of defective and electro-mechanical meters will also be provided by the Nodal officer of the project to the Turnkey Contractors centrally.
- 8.6 The Chief Engineer/PD&C instructed the turnkey contractors to provide the below mentioned deliverables at the earliest:
 - a. PERT Chart for each project be submitted immediately.
 - b. Manpower Deployment Plan against each project to be submitted before start of work and the same has to be adhered upto the completion of work.
 - c. Monthly Progress Report (MPR) is to be submitted by the 10th of every month having details with all completed work, ongoing and scheduled activities for next month.

- d. The details of approved/ empanelled vendor from where materials are to be procured be submitted at the earliest and if any empanelment is to be done, then the required documents of the vendor be submitted for empanelment to PD&C wing.
- e. GTP / Drawings and Manufacturing Quality Plan (MQP) and Manufacturer's Authorization form (duly notarized and registered) of approved / empanelled vendor are to be submitted for approval before raising any inspection call.

The project wise / firm wise review of Projects is as under:-

9. Integrated Power Development Scheme (IPDS)

9.1 M/s Ridhi Sidhi Electrical Engg. & Const. Co., Sirsa

TED-252 (IPDS Sirsa):- The work was allotted to the turnkey contractor LOA 31.03.2017. The firm has intimated that foot survey and vendor finalization is under progress. The firm intimated that some changes in BOQ are required while carrying out the foot survey. The Director Projects directed that the SE/Op Sirsa, shall look in to the matter and resolve the contractor's problem and submit the proposal with proper justification to CE/PD&C, DHBVN, Hisar.

9.2 M/s Agarwal Traders, Behal, Bhiwani

TED-254 (IPDS Bhiwani and Narnaul) and TED-270 (IPDS 33 kV Substation, Khera, (Bhiwani)): The work was allotted to the turnkey contractor vide LOA dated: 20.03.2017 for Narnaul & Bhiwani circle and vide LOA dated 27.04.2017 for 33kV Sub-Station, Khera (Bhiwani). The firm has intimated that foot survey with GPS coordinates is very tedious job and requested to accept the foot survey without GPS coordinates and also without indicating the existing infrastructure. The CE/PD&C elaborated the necessary of foot survey with GPS coordinates and further intimated that as per IPDS/ DDUGJY guidelines, the existing infrastructure through GPS is compulsorily to be mentioned in the foot survey and without that there may be problems during closure of the projects. The Director/Projects directed to the firm to expedite the completion of foot survey with GPS coordinates along with existing infrastructure and ensure to submit the same to the concerned nodal officer.

9.3 M/s Duhan Elect. Works, Hisar

TED-258 (IPDS Palwal):- The work was allotted to the turnkey contractor vide LOA dated: 27.04.2017. The firm has intimated that foot survey is under progress and shall be submitted within one month. The Director/Projects directed to the firm to expedite the completion of foot survey through GPS coordinates in time.

9.4 M/s Duhan Electrical Pvt. Ltd., Hisar

TED-253 (IPDS Hisar):- The work was allotted to the turnkey contractor vide LOA dated: 31.03.2017. The firm has intimated that foot survey is under progress and near to completion and shall be submitted to SE/OP, Hisar shortly. The Director/Projects directed to the firm to expedite the completion of foot survey through GPS coordinates in time.

9.5 M/s SKG Elect. & Const. Co., Narnaul

TED-255 (IPDS Rewari): The work was allotted to the turnkey contractor vide LOA dated: 27.04.2017. The firm has intimated that they are not aware about the GPS technology and filed officials are also not cooperating for conducting the foot survey. The CE/PD&C directed the nodal officer of the project to sensitize all the field officers about the IPDS scheme guidelines and nodal officer has to take personal attention for successful implementation of the project and full cooperation / information be given to the turnkey contractor. CE/PD&C also directed to the firm that material inspection call be raised only after finalization of the vendors.

10. Deen Dayal Upadhayay Gramin Jyoti Yojna (DDUGJY)

10.1 M/s Ridhi Sidhi Electrical Engg. & Const. Co., Sirsa

TED-241 (DDUGJY Sirsa) & TED-242 (DDUGJY Fatehabad):- The works were allotted to the turnkey contractor vide LOA dated 31.03.2017 for Fatehabad District and vide LOA dated 02.03.17 for Sirsa district. The firm has intimated that foot survey is under progress, but while carrying out the foot survey jointly with PMA certain major observations were noticed e.g. provision of VCB was not as per the supplementary DPR, the work in certain villages has already been covered under Mahra Gaon Gajmag Gaon etc. and the details have been submitted to the office of CE/PD&C, DHBVN, Hisar. The Director/Projects directed to the firm, to continue the foot survey

with GPS coordinates in line with the supplementary DPR. The Director Projects further directed to CE/PD&C that the issues raised by the firm are serious in nature, and needs to the decided by taking up the matter with REC.

10.2 M/s Agarwal Traders, Behal, Bhiwani

TED-240 (DDUGJY Jind), TED-244 (DDUGJY Bhiwani) & TED-246 (DDUGJY Rewari):- The works were allotted to the turnkey contractor vide LOA dated 31.03.2017 for Jind District, vide LOA dated 02.03.17 for Bhiwani district and vide LOA dated 27.04.17 for Rewari district. The firm has intimated that the foot survey is under progress and various material inspections against Jind and Bhiwani have been got carried out and erection of material has already been started in these two no. projects. The Director/Projects also directed to the firm, to expedite the completion of the foot survey with GPS coordinates inline with the supplementary DPR against all the awarded projects.

10.3 M/s Duhan Elect. Works, Hisar

TED-243 (DDUGJY Hisar), TED-247 (DDUGJY Gurugram):- The works were allotted to the turnkey contractor vide LOA dated 31.01.2017 for Hisar District, vide LOA dated 27.04.17 for Hisar district The firm has intimated that the foot survey is under progress and various material inspections have been raised / got carried out and erection of material has already been started in Hisar project. The Director/Projects also directed to the firm, to expedite the completion of the foot survey with GPS coordinates inline with the supplementary DPR against all the awarded projects.

10.4 M/s SKG Elect. & Const. Co., Narnaul

TED-245 (DDUGJY Mohindergarh):- The work was allotted to the turnkey contractor vide LOA dated 02.03.2017 for Mohindergarh district. The firm has intimated that they are not aware about the GPS technology and field officials are also not cooperating for conducting the foot survey. The CE/PD&C directed the nodal officer of the project to sensitize all the field officers about the DDUGJY scheme guidelines and nodal officer has to take personal attention for successful implementation of the project and full cooperation / information be given to the turnkey contractor. CE/PD&C also directed to the firm that material inspection call be raised after finalization of the vendor.

10.5 M/s MNC Electricals Pvt. Ltd., Faridabad

TED-248 (DDUGJY Faridabad), TED-249 (DDUGJY Mewat) and TED-250 (DDUGJY Palwal):- The works were allotted to the turnkey contractor vide LOAs

27.04.17 for Faridabad, Mewat and Palwal district. The firm has intimated that the foot survey is under progress. The CE/PD&C directed to the firm, to expedite the completion of the foot survey with GPS coordinates inline with the supplementary DPR against all the awarded projects. The Director/Projects further directed to the nodal officers of projects (i.e. concerned SE/OPs) that it must be ensured that there should not be any dulicacy of work being executed in the projects under RE-DDUGJY scheme and new projects under DDUGJY scheme.

11. RE-DDUGJY Projects (Erstwhile RGGVY Projects)

11.1 M/s MNC Electricals Pvt. Ltd., Faridabad

- a) TER-18 (RE-DDUGJY project of Gurugram District):- The work was allotted to the turnkey contractor vide LOA dated 31.01.2017. The firm has intimated that foot survey is under progress and various material inspection has been raised / carried out and erection of material has been started. The firm has intimated that due to changed scenario, there are two no. SE/Operation in Gurugram district and as such there are two nodal officers as per tender document. The firm requested to nominate one no. nodal officer instead of two no. for better monitoring of the projects in RE-DDUGJY and DDUGJY projects. The Director/Projects decided that the XEN/Works under SE/OP, Gurugram-I shall be the nodal officers for execution of the projects under IPDS/ DDUGJY / RE-DDUGJY in both Gurugram Circles i.e. Gurugram-I and Gurugram-II.
- b) TER-20 (RE-DDUGJY project of Palwal District):- The work was allotted to the turnkey contractor vide LOA dated 15.11.2016. The firm has intimated that the foot survey has been submitted in the office of CE/PD&C and various material inspections have been raised / carried out and erection of material is in full swing. The Director/Projects directed to the firm to expedite the execution of work for timely completion of the project.
- c) TED-263 (RE-DDUGJY project of Faridabad District):- The work was allotted to the turnkey contractor vide LOA dated 02.03.2017. The firm has intimated that foot survey is under progress and various material inspection has been raised / carried out and erection of material has been started. The Director/Projects directed to the firm to expedite the execution of the work for timely completion of the project.

12. Proposed 33 kV Sub-stations under DDUGJY :-

It was conveyed by CE/PD&C that all the 11 kV works under DDUGJY scheme has been awarded to various turnkey contractors and such it is necessity of time to award the 33 kV sub-stations proposed under DDUJGY immediately without any delay to avoid any complication. The status of each proposed 33 kV Sub-stations were discussed and following was decided:-

13. General Instruction for the turnkey contractors for IPDS / DDUGJY :-

- i. Various decisions taken during earlier two no. kick off meetings (copy enclosed) shall have to be followed by all the stake holders of DDUGJY and IPDS projects.
- ii. It has been decided that concerned XEN/Operation has to depute concerned SDO/Operation along with a experienced / capable and technically sound Junior Engineer of respective sub-division for timely completion of foot survey for the projects to be executed under IPDS and DDUGJY scheme. The concerned XEN/Operation shall intimate the details of respective SDO and JE sub-division wise to CE/PD&C, DHBVN, Hisar as well as to the nodal officer. It was directed to carry out the foot survey with GPS coordinates (jointly with Operation staff, representative of PMA and Turnkey contractor).
- iii. It was decided that the concerned turnkey contractor shall expedite the completion of foot survey with GPS coordinates along with existing infrastructure and ensure to submit the same to the concerned Nodal Officer.
- iv. It was decided that sub-division Review Meeting be called weekly at the level of Nodal Officer and at the level of the CE/PD&C monthly.
- v. Nodal officers were also directed to take necessary action for successful implementation of the DDUGJY / IPDS projects. The general role and responsibility at each level has been prepared by the office of CE/PD&C, DHBVN, Hisar and the hard copy of the same was handed over to the Nodal Officers /representative of Nodal Officers. However, after getting the approval from management the same shall be uploaded on the Nigam's webportal along with other DUGJY/ IPDS guidelines.
- vi. Concerned SE/OPs shall finalize the land for the 33 kV sub-stations to be executed under IPDS and DDUGJY scheme within 7 days so that tendering process for the same could be initiated.
