Sh. Ram Kumar S/o Sh. Shree Chand, V&PO Sandwa Tehsil Tosham Distt. Bhiwani applied for an electricity connection vide application no.B-14-514-84 under SDO (OP) No.1 S/Divn., DHBVN, Tosham, hence, this Forum has jurisdiction to hear the complaint.

Sh. Rajinder Singh S/o Sh. Sher Singh Village Pataudi Kalan PO Sandwa Tehsil Tosham Distt. Bhiwani applied for an electricity connection vide application no. B14-914-109 under SDO (OP) No.1 S/Divn., DHBVN, Tosham, hence, this Forum has jurisdiction to hear the complaint.

Complainant has filed the present complaint stating therein that he had applied for a new tube well connection and had completed all the due formalities along with all the due payments. But, the respondent SDO has not released his connection whereas connection to his junior applicants have already been released. He approached Nigam authorities for the same but, all in vain. He has therefore requested the Forum to redress his complaint.

The complaint was forwarded to the Nodal Officer for filing the written reply of the Nigam and both the parties were asked to appear before the Forum on 25.08.2020 at Bhiwani for hearing of the case.

The proceedings were held on 25.08.2020 through video conferencing at Bhiwani. The complainant and respondent SDO were present. SDO placed on record seniority list of applicants which was prepared on the basis of date & time of payment of motor cost made by the applicants online. As per seniority, complainant name appears at sr.no. 162 out of total 532 applications. Respondent SDO further stated that the complainant had completed all due formalities. Seniority list of 532 applicants had been sent to CE/Commercial and CE/MM, DHBVN through proper channel for procurement of motors of required BHP/load. As on date, 375 no. applicant wise motors out of 532 irrespective of seniority, have been received through Stores of DHBVN and almost all have been installed. He further stated that basis of selection of 375 no. applicants out of 532 was not known. Complainant was not satisfied with the reply of respondent SDO. Forum directed the respondent SDO to visit the office of C.E. (Commercial)/CE (MM) to find out the following and apprise the Forum through his Xen. within seven days.

1. Basis of procurement of motors, reasons for not following the seniority prepared on the basis of on-line deposition of motor cost and the criteria adopted for earmarking the motors to different applicants by leaving some of the applicants in between
2. Timeline of procurement of motors of remaining applicants.

Forum further directs respondent SDO to initiate the execution process if motors are to be procured by the Nigam in 15 days so as to release the connection without further delay.

The proceedings held on 28.09.2020 at Bhiwani. The complainant and representative of respondent SDO were present. SDO replied vide memo.no. 4417 dated 18.09.2020 stating therein that purchase order for motor pump set of the complainant has been issued by CE/MM, DHBVN, Hisar and motor is likely to be received in next fifteen days. As per Lab. report, only (4x20MF) units were shown consumed whereas in the load survey report, this was shown for the slot of half hour (10 PM to 10.30 PM) on dated 19.04.2019 and further load was showing in various slots. So, the correspondence was made with M&T Lab. to review the matter as total consumption for the period 8.1.2019 to 27.07.2020 was not justified. As such, the amount of Rs.1039646/- was charged as per sales circular no. 14/2017 on dead stop meter and reading not available by taking 80% load for fixed charges. Forum directed respondent SDO to obtain M&T Lab. revised report to approach meter supplier firm to retrieve the consumption data from the date of connection to date and apprise the Forum with detailed reason for not taking reading/supervising the connection since April, 2019. Now to come on next date of hearing on 29.10.2020. Complainant was also directed to deposit at least 40% of the disputed amount before the case is discussed again on the next date of hearing on 29.10.2020.

The proceedings held on 29.10.2020 at Bhiwani. Complainant and respondent SDO were present. SDO did not submit reply, however, he informed that the complainant has not deposited 40% of disputed amount in compliance of Forum direction. Forum gave last opportunity to the complainant to deposit at least 40% of the disputed amount within 20 days failing which the case will be decided accordingly.

no.42/001256 & no.44/001256 respectively and placed on record copy of the same. Forum directed respondent SDO to submit detailed reply as per earlier directions within fifteen days.

SDO submitted his reply stating therein that complainant never approached in-person nor even telephonically informed him that his bill were not received since the date of his connection.He also stated that neither the Billing/ reading agency nor the concerned area incharge(JE) apprised the matter.Consumer clerk also did not send any advice in this regard. Load survey data of meter placed on record.he representative of the complainant denied the facts. Forum directed respondent SDO and the complainant to appear before the forum on next date of hearing along with complete details for arguments. Now to come on the next date of hearing on 29.01.2021.
