3. On promotion, the above named officials mentioned at Sr. No. 1 to 11 shall remain on probation for a period of one year from the date they assume the charge of AE. The earlier promotion of the above named officials shall not confer upon them any right to claim seniority over those who may otherwise be senior to them in general category or reserved category.
