

9.5 Grant of travel concession for visiting any place in India for the State Government Pensioners.

(Copy of C.S. Hr. No. 13/19/2008-2SII, dt.19.07.2012)

I am directed to invite your attention to State Government letters of even number, dated 29th October, 2009, 19th May, 2010 and 2nd June, 2011 on the subject cited above and to say that one month's pension as travel concession for visiting any place in India would be admissible to the State Govt. pensioners in a block of four years and the first block was 2008-2011 and the subsequent blocks shall be 2012-

2015, 2016-2019, 2020-2023 and so on. The matter has further been considered by the State Government and it has been decided that if this facility is not utilised during the block of four years i.e. 2008-2011, it can be carried forward to the 1st year of the next block of four years upto 31.12.2012.

2. This may be brought to the notice of all the concerned for strict compliance.
