

Subject: Revision of grant of Special Allowance to all Safai Karamcharies working in various Departments/Public Undertakings/Municipal Committees in the State.

Whereas rates of Special Allowance to all Safai Karamcharies working in various Departments/Public Undertakings/Municipal Committees in the State were revised vide Finance Department letter No. 4/2/2009-5FR (FD) dated 27.08.2014 on the basis of the recommendations of 6th Central Pay Commission.

Now, the State Government has decided to revise the existing rate of Special Allowance to all Safai Karamcharies working in various Departments/Public Undertakings/Municipal Committees in the State @ Rs.625/- (Rs. Six hundred twenty five only) per month on the basis of the recommendations of the 7th Central Pay Commission.

Other terms and conditions shall remain unchanged.
