
Subject: Haryana Civil Services (Assured Career Progression) First Amendment Rules, 2020.

No. 1/20/2016-SPR(FD).— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Assured Career Progression) Rules, 2016, namely:-

1. These rules may be called the Haryana Civil Services (Assured Career Progression) First Amendment Rules, 2020.
2. These rules shall come into force w.e.f. 1st January, 2016.
