

**Subject: Extension of Validity of OPD card for reimbursement of Medicines for chronic diseases in view of the Corona Virus (COVID-19) Infection.**

Sir/Madam,

I have been directed to invite your kind attention to the subject mentioned above and to state that in view of the Corona Virus Disease (COVID-19), all out efforts are made by the Government to contain its impact by instituting measures at community as well as at individual level. Guidelines for maintaining social distancing between individuals have already been issued by the Government.

In the spirit of above guidelines the undersigned is directed to convey that the Haryana Govt. employees/ pensioners/ family pensioners and their dependents having chronic diseases may purchase medicines on existing prescription during the period from 22.03.2020 to 30.06.2020.

The medical reimbursement bills for chronic diseases for the duration from 22.03.2020 to 30.06.2020 may be reimbursed without renewed prescription on OPD cards.

That this relaxation is being made to help State Government employees/ pensioners/ family pensioners and dependents in view of extraordinary conditions due to COVID-19 and will not be cited as precedence in future.

These instructions will be applicable from 22.03.2020 to 30.06.2020 and may be downloaded from the Health Department Web Site (<http://haryanahealth.nic.in>).
