**Sub: - Revised ranking list of technical subordinates who have acquired AMIE/BE 03 years diploma /degree in Electrical Engg. but are working on lower post than JE beyond 01.08.2010 to 31.07.2011.**

Pease refer to SE/Admn., office memo No. ch-111/GM/Admn./REG-18 /Vol-IV dated 13.07.2012 and super session of this office memo No. Ch-05/SE/HR/CM/7701/2020 dated 24.08.2020 on the subject cited above.

In this connection, it is intimated that Sh. Dinesh Kumar ALM and Others has filed a court case in the Hon'ble Punjab & Haryana High Court Chandigarh bearing CWP No. 7860 of 2013 titled Dinesh Kumar Vs DHBVN regarding inserting their names in the ranking list and consider the claim of the petitioners for promotion on the post of JE with all consequential benefits under 25% quota. The same case is being defending by the office of SE/Admn. DHBVN, Hisar, as the ranking list on that time was prepared and circulated by his office.

Now the Hon'ble Punjab & Haryana High Court, Chandigarh has passed a judgment vide its order dated 25.08.2020 which is reproduced as under:-

***"In deference to the order dated 21.08.2020, the chairman-cum-Managing Director of respondent-Corporation, has joined the web meeting. He is informed the Court that the petitioners have been granted the benefit of the judgment passed by the Hon'ble the Supreme Court in Civil Appeal No. 17922 of 2017, and they have been restored at seniority positions 25 and 28 in the seniority list.***

*Learned senior Counsel appearing for the petitioners has submitted that the persons who are placed below the petitioners in the seniority list have already been promoted to the next higher post. The Chairman-cum- Managing Director of the respondent-Corporation, has assured the Court that he would take necessary step within a period of two months from today in accordance with law to redress this grievance of the petitioners.*

**Keeping in view of the aforesaid facts, the present writ petition is disposed of".**

Accordingly the name of the technical subordinates who have acquired 3 years diploma/degree through IME Bombay inserted in the ranking list of technical subordinates for the period 01.08.2010 to 31.07.2011. It is also added that Sh. Dinesh Kumar, ALM & Vijay Kumar, ALM had given ranking No.25 and 28 in the ranking list of technical subordinates for the period from 01.08.2010 to 31.07.2011, but the same ranking list was revised as per order dated 16.05.2017 in CWP No. 14393 of 2014 titled Pardeep Sathi & Others Vs DHBVN, & Others before Hon'ble Punjab & Haryana High Court, Chandigarh. As such the ranking No. 30 & 34 hereby assigned in the ranking list of technical subordinates for the period from 01.08.2010 to 31.07.2011 in respect of Dinesh Kumar, ALM & Sh. Vijay Kumar, ALM.
