Please refer to this office Memo No. Ch.-53/SE/HR/CEN-7/Vol-V dated 23.07.2020 on the subject noted above.

In this connection, it is intimated that Sh. Dinesh Kumar ALM and Others has filed a court case in the Hon'ble Punjab & Haryana High Court Chandigarh bearing CWP No. 7860 of 2013 titled Dinesh Kumar Vs DHBVN regarding inserting their names in the ranking list and consider the claim of the petitioners for promotion on the post of JE with all consequential benefits under 25% quota.

Now the Hon'ble Punjab & Haryana High Court, Chandigarh has passed a judgment vide its order dated 25.08.2020 which is reproduced as under:-

"In deference to the order dated 21.08.2020, the chairman-cum-Managing Director of respondent-Corporation, has joined the web meeting. He is informed the Court that the petitioners have been granted the benefit of the judgment passed by the Hon'ble the Supreme Court in Civil Appeal No. 17922 of 2017, and they have been restored at seniority positions 25 and 28 in the seniority list.

Learned senior Counsel appearing for the petitioners has submitted that the persons who are placed below the petitioners in the seniority list have already been promoted to the next higher post. The Chairman-cum- Managing Director of the

respondent-Corporation, has assured the Court that he would take necessary step within a period of two months from today in accordance with law to redress this grievance of the petitioners.


Keeping in view of the aforesaid facts, the present writ petition is disposed of".
