OFFICE ORDER

In exercise of powers conferred under Section - 56 (3) (vi) of Haryana Electricity Reforms Act - 1997, read with the Electricity Act - 2003, Article 46 of the Articles of Association of DHBVN and all other enabling powers in this behalf, the administrative powers under para No. 16 & 24 of the Office Order No. 97/GM/Admn dated 30.05.2013 entrusted to the Chief General Manager/HR & Admn (now Chief Engineer/HR & Admn.), DHBVN are hereby revised with immediate effect as under:-

- 16A The administrative powers to grant permission for private visits to abroad by DHBVN officers for the rank of AE/AEE & equivalent ranks, are hereby delegated to the senior most Director of DHBVN.
- 16B The administrative powers to grant permission for private visits to abroad by DHBVN officers for the rank of XEN & above/ equivalent ranks, shall lie with the Managing Director/ Chairman-cum-Managing Director, DHBVN, Hisar.
- 24A Retention beyond 50/ 55 years of age in DHBVN service for officers of the rank of AE/AEE & equivalent ranks, shall be decided by the senior most Director of DHBVN.
- 24B Retention beyond 50/ 55 years of age in DHBVN service for officers of the rank of XEN & above/ equivalent ranks,

shall be decided by the Managing Director/ Chairman-cum-Managing Director, DHBVN, Hisar.

The existing orders/ instructions connected with "Delegation of Powers" contained in orders/ circulars issued from time to time regarding the above categories of officers shall be deemed to have been modified/ substituted to the above extent.
