

Subject: CWP No. 5663 of 2018 titled as Pawan Kumar V/s State of Haryana & others.

Attention is drawn to judgment dated 08.03.2018 passed in subject cited case vide which the Hon'ble High Court decided the case in favour of Nigam. Petitioner has filed appeal for quashing of the advertisement No. 3/16 dated 20.02.2016 wherein only those candidates having 3 year diploma in electrical/electronic engineering from any institute recognized by AICTE or by State Board of Technical Education have been considered eligible for the post of grid Sub Station on Operator in the department.

It is an important judgment on the issue that advertised qualifications cannot be departed from the terms and conditions of any selection process together with the criterion adopted has to be scrupulously followed by adherim to the essential qualification prescribed under the rules and reflected in the advertisement. Besides, the rules of the game cannot be changed when the game is being played. Whatever adjustment was to be made has been devised for the


