

<b>Name of Post</b>	<b>Norms</b>
SSA	One for each Sub-Station
ASSA	Two for each Sub-Station
SA	Three for each Sub-Station
JE (Sub-Station)	One for each Operation Division for upto 4 Sub-Stations and additional one JE (Sub-Station) for upto additional 4 Sub-Stations in a Division.


In future, the additional posts as per notified norms will automatically stands created with coming up of new 33 KV Sub-Station in DHBVN.
