I am directed to invite your kind attention on the subject noted above and to inform that the Government of India has developed Aarogya Setu mobile application for staying informed and alert against COVID-19. The application is aimed at augmenting the initiatives of the Government of India, particularly the Department of Health, in proactively reaching out to and informing the users of the application regarding risks, best practices and relevant advisories pertaining to the containment of COVID-19.
