

I am directed to refer to the subject noted above and to intimate that the matter regarding issuance of Hindu Dogra Community certificate was under consideration of the Haryana Government. After due consideration the Government has decided to issue "Hindu Dogra Community Certificate" to the Youths of the Oustees of Bhakra Dam who have been settled in Haryana as per rehabilitation Plan for enrolment in the Army and Para Military Forces only in case they produce oustees certificates before the SDM/ Deputy Commissioner of jurisdiction.

The Certificate shall be valid only for the purpose of recruitment in Indian Defence Forces/ Central Armed Police Forces.
