

In exercise of powers conferred under Section – 56(3) (vi) of Haryana Electricity Reforms Act – 1997, read with the Electricity Act - 2003, Article 42 of the Articles of Association of DHBVN and all other enabling powers in this behalf, the Dakshin Haryana Bijli Vitran Nigam (DHBVN) is pleased to make the following amendments/ additions/ deletions/ substitutions in Regulation 2.0 of the Recruitment and Promotion Policy of Legal Wing as notified by erstwhile HSEB vide Notification No. 88/REG-64 dated 24.01.1991 (as applicable to DHBVN) for the post of Assistant Law Officers (ALOs), with immediate effect:-

- 2.4. The post of Assistant Law Officers (ALOs) is hereby downgraded from Class-II/ Group “B” (Gazetted) posts to Class-III/ Group “C” (Non-Gazetted) posts in DHBVN.
