**No.50/Reg-43** In exercise, of Power conferred under clause- C, Section-79 of the Electricity (Supply) Act-1948 read with Haryana Electricity Reforms Act-1997 and all other enabling powers in this behalf, the Dakshin Haryana Bijli Vitran Nigam Ltd. is pleased to make the following amendments/additions/deletions in the Recruitment & Promotion Policy of Audit & Accounts Wing Notified by erstwhile HSEB vide Notification No.56/REG-48/L-2 Dated 09.03.1990 regarding qualification of Accounts Clerks and Divisional Accountant/Revenue Accountants as under:-

**1.0 Accounts Clerk:-**

- 1.1 The post shall be filled up by direct recruitment from persons having the following qualifications:-
- a) Bachelors Degree in Commerce with at least 50% marks from any University recognized by the State Govt. of Haryana.
  - b) Hindi upto Matric standard.
  - c) Should have undertaken at least one-year Diploma Course in computer from any institution recognized by the State Govt.

**4.0 Divisional Accountant / Revenue Accountant:-**

- 4.1. 50% posts shall be filled up by direct recruitment from the persons having the following qualifications:-
- I) Bachelor's degree in Commerce with at least 60% marks from any University recognized by the State Govt. of Haryana. Candidates possessing higher qualification would be preferred.
  - II) Must have passed Hindi upto Matric standard.
  - III) Should have undertaken at least one-year diploma course in Computer from any institution recognized by the State Govt.
  - IV) The criteria of computer qualification shall also apply for posts of Divisional/Revenue Accountant to be filled up from promotion quota.

The above Notification supersedes all the previous orders/ instructions issued by the erstwhile HSEB/Nigam regarding qualification for recruitment of Accounts Clerks & Divisional/Revenue Accountants as well as for promotion as Divisional /Revenue Accountants from time to time.
