In partial modification of Office Order No.7/Reg-9/SE/Admn. dated 06.09.2001, the Dakshin Haryana Bijli Vitran Nigam Ltd. is pleased to make the following amendments in Sub Clause-3 of Clause (iii) of Regulation-12 of "HSEB Allotment of Residential Regulation, 1980 (Applicable to DHBVNL):-

Sub Clause-3 of Clause (iii) of Regulation-12 of the ibid Regulations shall be amended as under:-

Events (Sr. No.3)	Permissible period for retention of residence
Retirement or terminal leave.	Upto 4 months on normal rent, provided that the house occupied by the retiree is not an earmarked house, otherwise the house would be vacated within one month by the retiree. Further provided that the house occupied is not a leased accommodations, otherwise it would be vacated within one month of retirement.

This issues with the pursuance of decision taken by the Board of Directors in its meeting held on 26.02.2004.
