**Subject: Promotion of Helper Grade-II working in Workshop Organization to the post of Assistant Lineman as one time measure.**

The Board of Directors of DHBVNL considered the matter of promotion of Helper Grade-II, working in workshop Organization who possess the qualification of Matric with two years ITI Course, in its meeting held on 28.09.05 and decided that the 10 Nos. Helper Grade-II in the scale of Rs.2650/4000 working in Workshop Organization, possessing qualification of Matric with two years ITI course may be promoted to the post of ALM in the pay scale of Rs.4000/6000 in relaxation of the policy as a one time measure with the following terms & conditions:-

1. The concerned official will exercise option requesting for promotion to the post of ALM.
2. On promotion to the post of ALM these officials will be placed at the tail end in the seniority of existing ALMs.
3. The interested officials will give affidavit to the effect that on promotion to the post of ALM, they will forego their seniority in the present rank and have no objection to place them at the tail end of seniority of existing ALMs.
4. The option once exercised will be final and subject to no chance.

The above decision of the Board of Directors of DHBVNL and terms & conditions mentioned above may be brought to the notice of all 10 Nos. concerned Helper Grade-II working in Workshop Organization, who possess the qualification with two years ITI course. The willing officials will exercise their option requesting for promotion which will be forwarded by the concerned Head of Office alongwith requisite affidavit/undertaking and original certificates to the Controller of Stores, DHBVN, Hisar within 15 days of receipt of this letter, duly recommended. Options exercised after cut of date will not be considered.

The Controller of Stores will forward these documents to the CE/Operation, DHBVN, Hisar for further necessary action to issue their promotion orders to the post of ALM accordingly.

This issues in pursuance of the decision taken by the Board of Directors of DHBVN in its meeting held on 28.09.2005.
