

No officer/official will accompany the SPIO before the commission. The Managing Director has taken serious view in one of such cases and copy of same is enclosed for compliance please.

Today Mr. Premvir Singh, State Information Commissioner called me up and expressed his anguish over the fact that the SPIO of DHBVN has taken the issue of disseminating of information in a very casual way. SPIO was supposed to appear before the Public Information Commissioner, Haryana on 9-3-2011 but rather than going in person he has sent Sh. Rajinder Chauhan, Public Coordinator who was not even aware of the matter about which he appeared before the SPIO. Not only that the State Public Information Officer pointed out that whenever the SPIO, DHBVN appeared before him takes alongwith him 4 to 5 people and for any document which is asked for, he simply refer to his subordinate staff. This is a very unhealthy and a unprofessional approach. Needless to mention that State Information Commissioner is a Constitutional Authority and he operate under the purview of Right to Information Act. Such a casual and irresponsible action on the part of SPIO, DHBVN has tarnished the image of the Organisation and it in future may have serious repercussion. Hence, I would like to warn the official who deal with RTI in DHBVN to be very serious while dealing with the matters of Information Act and they will appear in person before the State Public Information Officer. The practice of carrying the whole staff will have to be done away not only here but also in other Branches of DHBVN.
