In exercise of powers conferred under Clause (c) of Section-79 of the Electricity (Supply) Act, 1948 and all other enabling powers in this behalf, the Dakshin Haryana Bijli Vitran Nigam, hereby makes the following amendments/additions under Para 4.4 in the Recruitment and Promotion Policy in respect of the employees of the Audit/Accounts Wings issued vide Notification Nos.56/REC-48/L-2 dated 9.3.90, 63/REG-48/L-3 dated 25.5.90, 77/REG-48/L dated 13.09.90, 133/REG-48/L-IV dated 6.2.92 and 202/REG-48/L-V dated 23.01.96: -

- 4.4** The following categories of employees will be eligible to appear in the Divisional/Revenue Accountant/Section Officer (Part-I) Examination.
- a) Apprentice Divisional/Revenue Accountants.
 - b) Commercial Assistants/H.C. Assistants.
 - c) Junior Accountants.
 - d) Qualified UDCs.
 - e) LDCs who have passed the Departmental Accounts Examination for Ministerial Estt., but have not so far been promoted as UDCs.
 - f) LDCs who have served for 10 years as LDCs and Steno Typists, Junior/Sr. Scale Stenographers who have completed 10 years service as Steno Typists/Junior Scale/Sr. Scale Stenographers but have not so far cleared the Departmental Accounts Examination for Ministerial Estt.
 - g) Meter Readers who have cleared the Departmental Accounts Examination for Ministerial Estt.
 - h) Officials who have already obtained exemption marks in one or more papers of Divisional/Revenue Accountants Examination, Section Officers Part-I Examination.

This issues in pursuance of the decision taken by the Board of Directors in its meeting held on 24.01.2008.
