Subject: Declaration of Government Offices, Commercial Establishments, Industrial Establishments as CFL/Energy Efficient Lighting Institute – circles allotted days of the week

In continuation of earlier circular on the subject cited above.

It has now been decided that the Circles shall also declare the following consumer categories as CFL on the same days as prescribed for them in earlier circular:

1. One Government Office
2. One Commercial Establishment having a dedicated transformer or load greater than 50 kw
3. One Industrial Establishment having a dedicated transformer or load greater than 70 kw

This will give an impression of “sweeping change” among the public and involve the general public in the campaign.
