
**Subject: Implementation of Safety Measures under DHBVN to avoid accidents (Instruction No. 60/MON/2014 dated 22.5.2014)-----  
--amendment thereof.**

Kindly refer this office Instruction bearing No. 60/MON/2014 dated 22.05.2014 vide which the detailed guidelines/ instructions for conducting the Safety Code Test were issued. As per the above instructions the authority for conducting Safety Code Test for AEs and other equivalent technical Gazetted officers working in field and Head office is CE/P&D, DHBVN, Hisar and with regard to JEs / AFMS / other technical subordinate staff, concerned SEs/OP were authorized for conducting the test. Now the matter regarding the authority for conducting the test of JEs / AFMS / other technical subordinates working in offices / circle, other than (OP) circles has been considered at management level and is decided as under.

"The authority for conducting the Safety code Test of JEs / AFMS / other technical subordinates working in offices / circles other than (OP) circle viz-a-viz Construction, M&P, COS, Energy Audit, IT, PD&C, MM, Commercial, R-APDRP etc. shall be decided at the level of Director Incharge concerned".

Other terms and conditions / guidelines of above instructions i.e. Instruction No. 60/MON/2014 will remain the same.
