**Subject: Levy of fuel surcharge adjustment (FSA).**

Please refer to Sales Circular No. D-10/2015 dated 23/4/2015 vide which the instructions regarding FSA to be levied w.e.f 1/4/2015 was issued.

As the slabs in the new tariff order issued by HERC on 07.05.2015 are different from the old slabs of the tariff applicable for FY- 2014-15. So, the matter has been reconsidered and decided to levy the FSA as under:-
